Dear Representative Westerman,

Hoping this note finds you and your family well after the storm we experienced in Northwest Arkansas on Wednesday, March 25th. I want to provide you a brief recap on how 40/29 and The Arkansas CW (KHBS/KHOG-TV) responded to this tornadic storm and why it is critical to preserve free, over the air broadcasting to as many of our viewers - and your constituents - as possible.

As always occurs in the case of a weather emergency, local television led the way in keeping everyone in the Northwest Arkansas area informed about the path of the thunderstorms and tornados. We take the responsibility of keeping our viewers safe very seriously at 40/29 and the Arkansas CW. Days before, we began warning people that March 25th had the potential to be a dangerous weather day. We showed our viewers when to expect the greatest threat and the areas that would most likely be impacted. In fact, the forecast – in timing, areas impacted, and severity – was similar for many of our viewers. As we demand and you expect, our news and weather teams were at the forefront of the local market response to this very dangerous tornadic storm.

In addition to providing plenty of advance warning allowing for appropriate preparation, 40/29 and the Arkansas CW also did the following:

- We called in all news staff to provide as much coverage as possible. We also deployed our “Storm Spotters” in strategic locations to make sure we covered our entire viewing area.
- 40/29 and The Arkansas CW provided emergency information via all of our platforms, on screen, on line and via mobile apps starting at 4:45pm and continued uninterrupted until 10:35pm. Our digital platforms had combined screen views of 831,529.
- We broadcasted a live stream to computer desktops via 4029tv.com, and most importantly via tablets and mobile devices for those who lost power but retained wireless service. 40/29 and The Arkansas CW’s storm coverage recorded 2,450 streamed views on Wednesday, many of whom we assume had lost power.

As you well know, cable and satellite are not able to provide precise weather coverage that local television stations deliver to our communities every day. When severe weather strikes, our certified meteorologists inform residents of precisely where the greatest danger lies and

the vital safety information necessary for all. After every storm, no matter the season, 40/29 and The Arkansas CW focuses on the local communities most affected and their efforts on regrouping and repairing the damage. There is still plenty of vital information to share with the area's viewers and local television is the best source to provide it. Our corporate investment by Hearst Television in journalists and broadcast equipment, coupled with Congress' preservation of the still vital local broadcast television system, provides the necessary financial infrastructure allowing KHBS/KHOG-TV to continue to provide critical news, weather and emergency information to our viewers. Thank you, once again, for your continued support of free, over the air local television.

In closing, I would like to share some of the comments we received from our local viewers via social media once the storm had passed. Comments like these further drive us to inform, protect, and serve the very important people we both care about so much.
